- 1. After submitting the detainee form, student can pay the fee online only after the Department Exam Coordinator has completed the verification process
- 2. If the course is not being offered in the current semester, then the student may be allowed by respective Department Exam Co-Ordinator through the portal only to attend the classes for the detained course, subject to the condition that the course syllabus should be having minimum 80% similarity with the course being offered currently in the department(s). Fee of Rs. 2,000/- per course for on-roll student(s) and Rs. 2,500/per course for non-on-roll student(s) will be applicable.
- 3. If student(s) wants to attend the classes for a detained course during his/her one semester Training in B.Tech. final year i.e. 7th/8th semester or MCA final year i.e. 4th semester, a student must undertake his/her training within 50 kms of college radius subject to permission from respective department.
- 4. Student(s) will have to submit the examination form and pay the applicable fee for detainee course(s) separately for End Semester Examination.
- 5. The student who has been struck-off due to any reason, can also fill the detainee form for any previous semester(s).
- 6. The name of the Department Exam Coordinator is displayed on the student's Academic Portal. Therefore, if a student encounters any challenges while registering online for course detention, he/she should reach out to the Exam Coordinator of their Parent Department.
